- 3. The International Advisory Board will perform the following tasks:
 - analyze the annual report on scientific research activities of the Institute;
 - consider additional information on the scientific research activities of the Institute;
 - analyze and propose the strategic scientific orientation of the Institute;
 - work on improving the status of the Institute as a scientific research organization at the regional and international level within the scientific fields in which it deals;
 - contribute to the long-term sustainability of scientific issues dealt with by the Institute in regional and international frameworks;
 - identify specific thematic "niches" the Institute should develop and be recognized for;
 - identify scientific ideas and thematic areas with high development potential;
 - consider and give an opinion on the medium-term program of scientific research activities of the Institute;
 - consider and give an opinion on the medium-term program for the development of the Institute's scientific youth;
 - give impetus to strengthening the international visibility of scientific results, i.e., the international excellence of the Institute (journals, thematic collections, monographs, etc.):
 - contribute to the improvement of cooperation with the environment (institutes, universities, economy, civil-society organizations, etc.);
 - identify potential international funds for financing the scientific research activities of the Institute.
